IDOC/ PACIFIC REPORT - 2015

2015 was a very busy year for our officials, both judges and stewards.

Our roles continue to be made more difficult as the world watches via instant social media, so opportunities for seminars and clinics take on an increasing importance. It was with this in min that I organized an IDOC workshop for our national Grand Prix judges at Hagen "Horses and Dreams meets Australia" early in 2015.

This was run in conjunction with an FEI refresher clinic.

We had judges from 10 countries and it was wonderfully supported by Ulli and Bianca Kasselman and Course Director ,Stephen Clarke.

A special thanks to Olivier for his organizational skills and endless patience.

So successful was this workshop that another is planned next year at Aachen with the enthusiastic support of Frank Kemperman,.

I have been busy working with a small IDOC sub-committee putting together a manual for Technical Delegates, Organizers and judges.

Much of the basis for this was originally done by Wojtek Markowski and Mariette Whitages for the TD clinic they presented in Poland. We are enlarging and updating the format into an "easy to use" hand book , with easy to find references for use at all FEI Dressage Championships. The first preliminary draft is completed.

Australia and new Zealand have formed the 'Oceania Equestrian Federation', and work is in progress organizing their first competition.

With Rio looming large on the horizon, both countries are hoping to be represented. Australia has already qualified for a team spot and NZ hopes to send an individual. Whilst we do not expect to medal, we hope for personal best scores from our representatives who always give their utmost when representing their country at Olympic Games.

It is a huge commitment for any combination from Australia or New Zealand, as for both countries, it means 6 months quarantine for their horses, before they are able to come back home, and shows their dedication to the sport.

It has been a privilege to have represented our region on the IDOC board for more than 8 years, and I would like to thank you all for your support.

Development and popularization of Dressage in the countries of Central and Eastern Europe (CEE)

Natallia Rubashko (BLR)

2015 has been rather successful year for our region.

The table below shows some statistics of dressage development in CEE countries. It doesn't comprise all CEE countries, only those one way or another presented in the FEI Data Base in 2015.

Events:

In 2015 only 9 countries among 18 CEE National Federation have held the Official International Dressage Events. It has been 52 events of different level or approx. 11% of all FEI Dressage events.

Most of them have been organized in Russia. The second is Poland and then Hungary. Totally it comprises 60% from all events in CEE.

In 2016 it plans to organize 129 events of different level (CDIYH / J / Y / P / Ch / U25 / 2*/3*/W).

Lithuania has held CDI-W first time. Only 8 riders from Lithuania, Estonia, Finland, Russia and Ukraine took part at the event but this event will be held in 2016 again. Since 2014 Estonia also holds CDI-W.

Such happened that last 2 years the political situation in Ukraine was not conducive to holding international events. Last events have been organized in 2013. But this year brings good news. Equestrian Federation of Ukraine plans to organize CDIJ in May and CDI-W in August. Wish them good luck.

There are 3 countries (Latvia, Romania and Serbia) which have riders and horses competing internationally but still have no International Dressage Events and FEI Officials.

The main difficulties with participation in Events in our region are connected with the borders between the EU countries and the former Soviet Union countries. Participants have a lot of problems while crossing the border. That's why not so many riders from the former SU countries can participate in the events in Europe. Also like riders from the EU have no desire to spend a lot of time with the horses on the border through there is an interest to come especially from Poland, Latvia, Lithuania and Estonia.

Equestrian federations of Belarus, Russia and Ukraine try to solve these problems but still not successfully. And the current situation with immigration is unlikely to improve something. Unfortunately, we expect the difficulties will increase.

Sport achievements:

Leading positions among CEE riders in the FEI Dressage ranking are occupied by riders from Russia. We can say that efforts of Equestrian Federation of Russia in developing Dressage bring the results.



Russian rider Inessa Merkulova with Mister X made significant breakthrough and now occupies 14th place in the FEI World Individual Dressage Ranking. It should also be noted a significant rise of other Russian riders that can provide them a chance to have a team for Olympic Games in Rio 2016.

Nowadays there are already hundreds of clubs in Russia engaged in the development of the equestrian disciplines, including Dressage. Such clubs as "Otrada", "New Century", "Maxima Stables" in Moscow are the most known. The appearance of private clubs that are interested in the development of Dressage provides a significant improvement in results.

Last year "Maxima Stables" organized many courses for riders, trainers and judges conducted by our colleagues - judges Raphaël Saleh, Maribel Alonso, Christof Umbach, Katrina Wuest; trainers Maik Kohlschmidt, Herr Peter Perlee, David Hunt, Tomas Sigtenbjerggaard and Dominique Filion.

One of such course has been organized in Belarus by private club "Piaffe" who invited Mariette Withages to share her knowledge among Belarusian riders, trainers and judges.

Also there are a sufficient number of private clubs in Ukraine, which invite the FEI judges for judging national Dressage events.

Such practice also exists in Estonia, Poland, Latvia, Lithuania. Of course, it helps to increase the level of riding and judging.

Officials:

The death of our great colleague and friend Wojtek Markowsky is a significant loss for our region. Now there is no FEI 5* judge representing CEE.

CEE now has a total of thirteen (13) 4* judges & nine (9) 3* judges.

The newest FEI 3* judges we would like to welcome are two judges from CZE - Simona FIALOVA and Gabriela VALERIÁNOVÁ - were successful at 2015 exam in Stuttgart. In 2014 Eva-Maria VINT-WARMINGTON (EST) and Natallia RUBASHKO (BLR) were successful in passing the examination also conducted in Stuttgart and got their FEI 3* and FEI 4* status accordingly.

2015 was successful for three new judges qualified to judge Young Horses competitions after exam in Vilamoura (POR). They are Eva-Maria VINT-WARMINGTON (EST), Mariya DZHUMADZHUK and Larysa VELYKA (UKR). Our congratulations are in order.

Concerning the FEI Officials 3 countries (Latvia, Lithuania and Serbia) have no any Dressage Officials. Moldova has five (5) Level 1 Dressage Stewards only.

The political situation in Europe and the future of the Schengen may create difficulties for the majority of our judges. While we hope that this will not happen.

Concerning my personal activity I have conducted four Seminars for National Dressage Judges in 2015: Bangalore (IND), with exam, together with Tim DOWNES (GBR) FEI 3*/4* Eventing Judge; Vazgaikemis (LTU), refreshment; Riga (LAT), refreshment; Delhi (IND) with exam.

And for the moment I'm continuing to develop the IDOC Web-site.

Therefore, I see an important part of this role is keeping up-to-date with current rules, regulations and ongoing education not only for the continued growth of the region, but also to effectively support the development of the sport in the Asian countries, as many of our Australian judges give clinics and workshops in the region.

I am looking forward to planning and creating further development pathways for both Judges and Stewards within the region, and plans are underway to hold a Pacific region workshop at Aachen in 2017.

Program

I have been involved in organization of Equestrian Events at all levels in Belarus for about 20 years. I've also been instrumental in the development of the sport not only in Belarus but in many other Eastern European Countries (Russia, Estonia, Lithuania, Latvia, Ukraine) since late 90s.

After getting my 3* status I have participated in the discussion of the Dressage Rules very actively and made some research concerning improvement of judging system since 2009 and nowadays.

According to my basic higher education as a Computer Science specialist I can make statistical and another kind of research from now onwards and develop and support the IDOC web-site.

So the main provisions of my program are the following:

- representing and defending the interests of dressage officials from Eastern Europe;
- disseminating technical information with regard to judging issues and dressage tests for them;
- providing guidance to officials in exercising their duties and responsibilities;
- further the education of dressage officials by conducting courses and seminars for the skills development of national dressage officials;
- monitoring the Rules for Dressage, providing input for their revision and organizing discussion of proposals among dressage officials from Eastern Europe;
- implementing of/and testing proposals concerning the refinement of requirements, assessments and judging procedures for dressage;
- making a different kind of research (including statistical) to test the proposals mentioned above if necessary;
- developing, upgrading and further administrating the IDOC web-site.

I feel that I have enough knowledge and experience to bring to Eastern European Judge Community and wish to put my name forward.
